



## Invitation for Bids

1. The **Republic of Uzbekistan** has received financing from the Asian Development Bank (ADB) towards the cost of **Solid Waste Management Improvement Project**, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to bidders from eligible source countries of ADB.
2. The **State Unitary Enterprise “MAXSUSTRANS”** (the “Purchaser”) invites sealed bids from eligible bidders for the supply of:

<b>Lot</b>	<b>Description of Good</b>	<b>Quantity</b>
Lot-1	Waste Collection Trucks with body volume 12 m <sup>3</sup>	25 pcs.
Lot-2	Waste Transfer Trucks for steel containers 27 m <sup>3</sup>	15 pcs.

Bidders are allowed to bid for one lot or combination of lots. Bid per item is not allowed and shall be rejected.

3. **International Competitive Bidding (ICB)** will be conducted in accordance with ADB’s **Single-Stage: One-Envelope (1S1E)** bidding procedure and is open to all bidders from eligible countries as described in the Bidding Document.
4. The Bidder must satisfy the following evaluation and qualification criteria stipulated in Section 3 –Evaluation and Qualification Criteria of the Bidding Document:
  - 4.1 **Contractual Experience**  
Successful completion as main supplier within the period since 2021 until the date of the Invitation for Bids of at least two (2) contracts for supply of special machinery each valued for Lot 1: min. US\$1,600,000 or equivalent; Lot 2: min. US\$1,440,000 or equivalent.
  - 4.2 **Technical Experience**  
The Bidder shall demonstrate that the goods offered have:
    - (i) been in production since 2021 until the date of the Invitation for Bids;

- (ii) been sold a minimum of: Lot 1: Seventy five (75) units; and Lot 2: Forty five (45) units. If supposed to award separately, or for the whole supply or any group of lots accordingly – an aggregate number of the goods since 2021 until the date of the Invitation for Bids; and
- (iii) been in operation since 2021 until the date of the Invitation for Bids.

#### 4.3 **Production Capacity**

The Bidder shall demonstrate that it can supply:

Lot 1: Waste collection trucks with the body volume not less 12m<sup>3</sup> (25 pcs);

Lot 2: Waste Transfer Trucks for transportation of containers with the volume not less 27m<sup>3</sup> (15 pcs).

#### 4.4 **Financial Situation**

The Bidder shall demonstrate soundness of the its financial position showing long-term profitability demonstrated through audited annual financial statements (balance sheet, income statement) or, if not required by the law of the Bidder's country, other financial statements acceptable to the Purchaser, for the period since 2021 until the date of Invitation for Bids. As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive.

#### 4.5 **Size of operation**

The Bidder shall demonstrate a minimum average annual turnover of production (or supply) of the special machinery for Lot 1: US\$3,000,000 or equivalent and for Lot 2: US\$2,700,000 or equivalent defined as total payments received by the Bidder for contracts completed or under execution over the period since 2021 until the date of the Invitation for Bids.

#### 4.6 **Cash flow capacity**

The Bidder shall demonstrate availability of or access to liquid assets, lines of credit issued by the serving financing institutes, and other finances sufficient to meet any possible cash flow requirement which is for Lot 1: US\$1,500,000 or equivalent and for Lot 2: US\$1,350,000 or equivalent that may arise during the execution of the contract.
