

# Invitation for Bids

- 1. The **Republic of Uzbekistan** has received financing from the Asian Development Bank (ADB) towards the cost of **Solid Waste Management Improvement Project**, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to bidders from eligible source countries of ADB.
- 2. The **State Unitary Enterprise "MAXSUSTRANS"** (the "Purchaser") invites sealed bids from eligible bidders for the supply of:

Lot	Description of Good	Quantity
Lot-1	Wheel Waste Collection Bins 1100 I	4,500 pcs.
Lot-2	Containers for Waste Transportation 20 m3	180 pcs

Bidders are allowed to bid for one lot or combination of lots. Bid per item is not allowed and shall be rejected.

- International Competitive Bidding (ICB) will be conducted in accordance with ADB's Single-Stage: One-Envelope (1S1E) bidding procedure and is open to all bidders from eligible countries as described in the Bidding Document.
- 4. The Bidder must satisfy the following evaluation and qualification criteria stipulated in Section 3 Evaluation and Qualification Criteria of the Bidding Document:

#### 4.1 **Contractual Experience**

Successful completion as main supplier within the period since 2020 until the date of the Invitation for Bids of: Lot 1: at least two (2) contracts for supply of steel bins each valued min. US\$1,152,000 or equivalent; Lot 2: at least two (2) contracts for supply of large steel containers each valued min. US\$672,000 or equivalent.

#### 4.2 **Technical Experience**

The Bidder shall demonstrate that the goods offered have:

- (i) been in production since 2020 until the date of the Invitation for Bids;
- (ii) been sold a minimum of: Lot 1: Thirteen thousand five hundred (13,500) units steel bins for collection of solid waste; and Lot 2: Five hundred forty (540) units large steel containers for municipal and construction waste since 2020 until the

date of the Invitation for Bids. If supposed to award separately, or for the whole supply or any group of lots accordingly – an aggregate number of bins and containers sold in the mentioned period; and

(iii) been in operation since 2020 until the date of the Invitation for Bids.

#### 4.3 **Production Capacity**

The Bidder shall demonstrate that it can supply: Lot 1: Waste collection bins with volume not less 1100l (4,500 pcs); Lot 2: Waste collection containers with volume not less 20m3 (180 pcs).

#### 4.4 **Financial Situation**

Bidder shall demonstrate soundness of the its financial position showing long-term profitability demonstrated through audited annual financial statements (balance sheet, income statement) for the period since 2020 until the date of Invitation for Bids.

#### 4.5 Size of operation

Bidder shall demonstrate a minimum average annual turnover of production (or supply) of bins and/or containers for Lot 1: US\$2,160,000 or equivalent and for Lot 2: US\$1,260,000 or equivalent defined as the total payments received by the Bidder for contracts completed or under execution over the period since 2020 until the date of the Invitation for Bids.

#### 4.6 **Cash flow capacity**

Bidder shall demonstrate availability of or access to liquid assets, lines of credit issued by the serving financing institutes, and other finances sufficient to meet any possible cash flow requirement which is for Lot 1: US\$1,080,000 or equivalent and for Lot 2: US\$630,000 or equivalent that may arise during the execution of the contract.
